KW Legacy to launch Christmas Cookie Exchange fundraiser



KW Legacy will launch its first-ever Christmas Cookie Exchange on Dec. 7, 2024, at 1 p.m. at St. George's Hall in Waterloo. The event aims to bring the community together in a festive spirit while raising funds for the charity's scholarship programs.

The Christmas Cookie Exchange invites local bakers to showcase their favourite holiday cookie creations. Attendees can sample the treats, vote for their top picks, and create holiday plates for their get-togethers and events. Tickets are \$20, and cookies are \$2 each. Proceeds will go directly towards KW Legacy's scholarship programs for local high school students.

"We are looking to give local bakers a chance to celebrate the season with their finest cookie creations while giving something back to the community," said Mike Denomme, KW Legacy's co-founder. "The best part of it is tasting some of the cookie creations and family recipes that people have been sharing for years. This is also a great way to help this Christmas while getting out with your friends and having some fun."

Attendees can look forward to door prizes, holiday giveaways from local sponsors, and a special visit from Santa Claus, making it an event the whole family can enjoy.

Since its founding in 2014 to support local charities, KW Legacy has raised more than \$1 million and awarded 96 scholarships, worth at least \$5,000 each. The organization continues to expand its impact through new fundraising ventures. It hosts a Recruitment Night every June but welcomes support and volunteers year-round.

Championing education and community connection since 2014

KW Legacy is a local organization that was founded in 2014 to support the Waterloo Region community. The first initiative was a St. Jerome University alumni event hosting a Golf for Scholarships fundraiser which quickly expanded to include all 15 local high schools in the region. The inaugural fundraiser raised more than \$100,000 for local high school graduates. Legacy scholarship recipients are school leaders who make an impact. They actively serve others and value connections with their community.

KW Legacy has raised more than \$1 million through nine tournaments at the Conestoga Golf and Country Club. The most recent tournament held in Sept. 2024 had more than 100 participants and raised a record \$100,000. As the organization gears up for its next golf event in Sept. 2025, it aims to surpass the \$1.1 million milestone in total donations.

Over the years, KW Legacy has awarded 96 scholarships worth at least \$5,000 each to qualified students in the region. Scholars are selected based on financial need, contributions to their school or community, participation in unique events, and general civic action. Applicants must also write an essay about their accomplishments and future goals. In 2024, 12 scholarships were awarded from more than 5,000 applicants. The scholarship application process begins each Jan.

In 2018, KW Legacy launched its Top Home Chefs initiative to support the Men's Suicide Council, identified by the Waterloo Region Suicide Prevention Council. The event showcases 50 local home chefs whose dishes are sampled by 450 attendees and judged by well-known local foodies. Since its inception, it has raised more than \$95,000, with the latest event in April 2024 raising \$50,000.

KW Legacy is a charity with zero overhead, so 100% of donations go directly to local causes. The organization plans to expand its impact by addressing affordable housing and providing smaller scholarships for Grade 8 students. It also seeks to partner with individuals and organizations to help them plan their legacies through wills or estate planning.

KW Legacy stays connected to the community through various events. These include annual recruitment nights in June, Meet the Parents nights introducing scholarship recipients and their families to mentoring opportunities, and a Sponsors Night and Volunteer Appreciation Event in Sept.

In addition to the regular charity events, KW Legacy will launch a new Christmas Cookie Exchange on Saturday, Dec. 7, 2024, at St. George's Hall in Waterloo. Local bakers will be invited to produce their favourite Christmas cookies, while attendees can taste, judge, and create their holiday treat plates. Admission is \$20 and cookies can be purchased for \$2 each. All proceeds will support the organization's scholarship programs. The event will feature door prizes, giveaways from local sponsors, and a visit from Santa.
